

**Instructions:**      **Appeal for Reinstatement**

1. This appeal form is only for students who have been Academically Dismissed after the current semester. Students who have been out for more then one semester only need to submit a re-entry form through the UWW Admissions Office.
2. Complete all sections of this appeal form. The Admissions and Academic Standards Committee will not consider incomplete appeal forms. This includes missing/wrong student ID numbers, missing signature/initials at the bottom of the form, or incomplete answers. Please check spelling and grammar before submitting.
3. **All forms are required to be emailed as a Word or PDF attachment to the Academic Standards email (acadstand@uww.edu). SharePoint documents are not accepted, the Word or PDF document must be attached to the email sent to acadstand@uww.edu.** Students who are requesting accommodations should contact the Academic Standards Office.
4. **Appeals MUST be received by the stated deadline. Late appeals are NOT accepted.** (There are three appeal cycles a year: January, June, and August). Specific days and times are on the Academic Standards website.
5. You may submit additional documentation to provide further explanation, letters of recommendation, copies of medical records, etc in support of your appeal. Please submit with your appeal electronically.
6. Decisions will be communicated by email to the students UWW email account.
