Re: Integration of UPS Policies into UW System Administrative Policy Series: July 2019 Update

This is intended to provide an update on the process of integrating the University Personnel System Operational (UPS) policies into the UW Administrative Policies and Procedures (SYS) policy series and to serve as a reminder of the July 15th go live date.

Summary

If you recall, UW System Administration (UWSA) is continuing the process of migrating all System-level policies below the Regent Policy Documents into the SYS policy series. What are currently UPS policies will become the 1200 series in the SYS policy set. This process results in no substantive changes to the policies, and the UPS/1200 policies will continue applying to all UW institutions, other than UW-Madison. To further simplify the policy development process, future changes to UPS/1200 series policies will go through the regular SYS policy review process. The 1200 series will go live on July 15, 2019. Between July 2019 and July 2020, the links to UPS policies will redirect to the new 1200 series. In July 2020, the links to the UPS policies will expire, meaning the deadline for UW institutions to update UPS policy references is July 2020.

UWSA is scheduled to be on-time in implementing and publishing the converted UPS policies into the SYS policy set. See Appendix A for a visual timeline of the process and the information below for a detailed description of what each phase entails. Phase 1: Design and Numbering

Phase 1: Design and Numbering, which is complete, included assigning a new number to the existing UPS policies to prepare for inclusion in the 1200 series of the SYS policy set. Those UPS policies solely intended to provide interpretation/implementation guidance

were converted to webpage format in the form of practice directives and will be housed on the UW System Human Resources website. A link to that website will appear as a header in the new 1200 series when the series goes live on July 15th. Please see Appendix B for the numbering scheme.

Phase 2: Preparing to Go Live

Phase 2: Preparing to Go Live entailed transferring UPS policies from PDF to webpage format, including reformatting the text and links within the policies to reflect the new numbering scheme. All policies and practice directives have been converted into webpage format and are currently being checked by the UW System Office of Human Resources to ensure that formatting was done correctly, and information is not missing. UW System Administration is currently checking cross-references within the UPS/1200 policy text and updating references to the old UPS numbering scheme to the new 1200 numbering scheme.


Phase 3: Go Live

The newly formatted policies will be published on July 15, 2019 and all existing links in documents and webpages will redirect to the converted policies. UWSA will begin updating the Regent Policy Documents and SYS policy references and links to UPS with the new SYS 1200 numbering scheme and links. In the communication email notifying campuses of the publication of the 1200 series on July 15, UWSA will include a list of links to be used to replace old UPS policies on their website.

Phase 4: Final Steps

Between July 15, 2019 and July 15, 2020, institutions and UWSA will need to update the links and references on their webpages and documents. This includes replacing old links to the UPS policies with the links to the new SYS 1200 series and updating any text/numbering on pages and documents. Institutions can begin this process at any point by creating a list of where the current links are located so they are easier to update after July 15, 2019. The current links will work until **July 15, 2020**, when the redirected links expire.
