New Paid Parental Leave Effective July 1, 2024

The Universities of Wisconsin is implementing a new Paid Parental Leave (PPL) policy that provides eligible employees with up to 6 weeks (240 hours) of paid time off within a 12-monht period (pro-rated if part-time) following a qualifying birth or adoptive event to allow time to bond with their new child, adjust to their new family situation and balance personal obligations that result from a birth or adoptive event. 

Please review your Legal Holiday balance after the Memorial Day Holiday processes, after June 7th, 2024. If you have any remaining hours in your Legal holiday bank, they are the past years floating holiday hours and must be used by June 30, 2024, or they will be forfeit as we roll into the next fiscal year on July 1,2024. In addition, all Personal Holiday and vacation carryover hours must be used by June 30, 2024. Only the hours you accrued in FY 23-24 will roll over to the new 24-25 fiscal year. Immigration

IMPORTANT: Immigration Information for International Faculty and Sponsoring Departments: Post 9-11 Security Checks/Administrative Processing

Note that any time an international faculty member applies for an H-1B travel visa abroad at a US Consulate, they risk being placed in "administrative processing" by the Department of State. These checks are also known as national security checks. The delays can be extensive (months) and there is no option to expedite the security checks which are in place for national security reasons. https://travel.state.gov/content/travel/en/us-visas/visa-information-resources/administrative-processing-information.html. One of our faculty members is currently experiencing this. Faculty are also required to respond to specific, detailed questions from the Consulate regarding their area of expertise, especially if the area is related to CS or IT.
