RESTRICTIONS

- 1. A maximum of two (2) transfer courses are allowed. No more than 50% of the certificate will be fulfilled using transfer courses.
- 2. In order to graduate with an investment certificate, a 2.0 GPA is required in the certificate.
- 3. Business majors must have a minimum GPA of 2.50 in the following areas: major requirements, combined transfer, and UW-Whitewater GPA, and in all subjects offered by the College of Business & Economics.
- 4. Certificate enrollment is limited to CoBE majors who have completed 60 credits & 2.50 CUM GPA
