Admissions Requirements:

Bachelor's or higher degree from a regionally accredited institution and minimum GPA of 2.75 overall undergraduate GPA or 2.90 in last half of undergraduate degree or 3.0 in graduate level coursework. Transfer Credit

If you have graduate credits that you would like to transfer into the program, you must complete the transfer credit form available on the UW-Whitewater Graduate Studies Admissions website. Please contact Dr. Lucinda Heimer, Program Coordinator, to discuss possible transfer credits.

Tuition:

UW-Whitewater Summer 2021 graduate tuition rate: \$511.81 per credit (in-state) or \$1060.82 per credit (out-of-state) plus the \$50 per credit online fee. All students participating in this master's degree will be charged the current graduate tuition rate. Graduate tuition rates for Fall 2022 and beyond have yet to be determined by the board of regents.

If interested in only taking a course or selected courses and NOT completing the entire master's degree, you may apply as a non-candidate for degree special student through the online application available at: apply.wisconsin.edu
